A recent case that you may have seen covered in the media, regarding the conviction of a disability worker for sexual assault, highlights the importance of the Commission's role in making the disability sector safer. The individual has been subject to a Prohibition Order from the Commissioner while we investigated his conduct.

We know most disability workers are highly committed and provide an excellent level of support to people with disability. However, we know there are times when people will have concerns and even when people with disability can be harmed.
