Release of VDWC and Board Annual Report 2024-2025

The Victorian Disability Worker Commission and the Disability Worker Registration Board of Victoria are proud to present their Annual Report 2024-25.

This report provides an update on the key achievements and milestones of both the Commission and Board and the work being done to build a safer, stronger disability sector in Victoria. We are also pleased to present a summary of highlights, 2024-25 At a Glance.

Some of our key achievements mentioned in the Annual Report are:

• 1,016 registered disability workers

- 6,740 people engaged through awareness education about disability worker regulation
- 51 Interim Prohibition Orders and 5 Prohibition Orders made.

Revised disability worker registration standards in effect

Revised disability worker registration standards took effect from 1 October 2025.

The standards apply to all applicants for disability worker registration and to registered disability workers.

The three registration standards are:

- Criminal history
- English language requirements
- Continuing professional development.

Registration standards promote a safe, sustainable disability workforce and high-quality disability services.

We reviewed and updated the registration standards to ensure they work well and meet the expectations of the disability sector. We listened to feedback from the disability community following a public consultation and made changes to make it easier for disability workers to understand and comply with the standards.

What's on in the sector

Updates to guideline for management of acute respiratory infection outbreaks in residential care facilities

The Department of Health has updated their <u>Management of acute respiratory</u> infection outbreaks, including <u>COVID-19</u> and influenza, in residential care <u>facilities</u> guideline.

This resource provides respiratory outbreak management advice for residential care facilities (including disability residential services) along with a list of downloadable resources. Key updates include:

- Revised recommendations on residents' release from isolation post-COVID infection
- Updated staff return to work recommendations post-COVID infection
- Updated testing advice for residents who are considered contacts of a COVID infection
- A simplified contact definition
- Streamlined outbreak closures for all Acute Respiratory Infections (i.e. COVID, influenza, RSV etc).

New resources on the Code of Conduct

In Victoria, all disability workers must comply with the Disability Service Safeguards Code of Conduct. This Code is the same as the NDIS Code of Conduct, promoting consistency about quality safe standards for disability workers. The NDIS Quality and Safeguards Commission (NDIS Commission) has

released new educational videos about the NDIS Code of Conduct, helping everyone to understand the expected conduct, behaviour and culture of workers. You can access these videos that outline obligations under the Code here:
